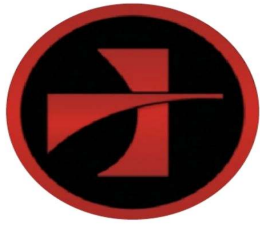

Intellectual Property Rights Terms and Conditions for Custom Vinyl Decals

1. Definitions

1.1 Proteus Corp Pty Ltd, the provider of custom vinyl decal services.

1.2 "Customer" refers to the individual or entity purchasing custom vinyl decal services from Proteus Corp Pty Ltd.

1.3 "Design" refers to any artwork, image, logo, text, or other creative material provided by the Customer for use in custom vinyl decals.

2. Ownership of Designs

2.1 The Customer retains ownership of any original Design submitted to Proteus Corp Pty Ltd for custom vinyl decal production.

2.2 Proteus Corp Pty Ltd does not claim ownership of the Customer's Design, but the Customer grants Proteus Corp Pty Ltd a non-exclusive, royalty-free license to use, reproduce, and modify the Design solely for the purpose of fulfilling the Customer's order.

3. Customer Warranties

3.1 The Customer warrants that they own or have the necessary rights to use and authorize Proteus Corp Pty Ltd to use the Design.

3.2 The Customer warrants that the Design does not infringe upon any intellectual property rights, including but not limited to copyrights, trademarks, and patents, of any third party.

3.3 The Customer agrees to indemnify and hold Proteus Corp Pty Ltd harmless from any claims, damages, or expenses arising out of any breach of these warranties.

4. Use of Designs

4.1 Proteus Corp Pty Ltd agrees to use the Design solely for the production of custom vinyl decals as requested by the Customer and not for any other purpose.

4.2 Proteus Corp Pty Ltd will not reproduce or distribute the Design for any purpose other than fulfilling the Customer's order without the Customer's prior written consent.

5. Intellectual Property Rights of Proteus Corp Pty Ltd

5.1 Any designs, templates, or artwork created by Proteus Corp Pty Ltd for the purpose of producing custom vinyl decals remain the property of the Proteus Corp Pty Ltd.

5.2 The Customer is granted a non-exclusive license to use such designs, templates, or artwork solely for personal use and not for commercial purposes unless otherwise agreed in writing.

6. Right to Refuse Service

6.1 Proteus Corp Pty Ltd reserves the right to refuse any work requested by the Customer at Proteus Corp Pty Ltd sole discretion.

6.2 Proteus Corp Pty Ltd may refuse to produce any Design that it deems inappropriate, offensive, or that it believes infringes upon the intellectual property rights of others.

7. Confidentiality

7.1 Proteus Corp Pty Ltd agrees to maintain the confidentiality of the Customer's Design and will not disclose it to any third party without the Customer's consent, except as necessary to

fulfill the order.

8. Termination

8.1 Either party may terminate this agreement upon written notice to the other party if the other party breaches any material term of this agreement and fails to cure such breach within 30 days of receiving notice of the breach.

8.2 Upon termination, Proteus Corp Pty Ltd will cease using the Customer's Design and return or destroy any copies of the Design in its possession, except as required to fulfill any outstanding orders.

9. Governing Law

9.1 This agreement shall be governed by and construed in accordance with the laws of [Your State/Country].

10. Amendments

10.1 Proteus Corp Pty Ltd reserves the right to amend these terms and conditions at any time. Any amendments will be posted on Proteus Corp Pty Ltd website and will become effective upon posting.

11. Acceptance

11.1 By submitting a Design to Proteus Corp Pty Ltd, the Customer acknowledges and agrees to these terms and conditions.
